Coursework for LPH Training Program Handbook

This handbook serves as a comprehensive guide, outlining the coursework essential for progressing through the Massachusetts Local Public Health Training Program (LPHTP), which encompasses specialized training for Food and Housing inspections. The program is structured into three tiers:

- Tier 1 Essential Knowledge with online learning modules
- Tier 2 Instructor Guided Learning featuring both instructor-led classroom and virtual sessions
- Tier 3 Applied Practice involving joint inspections.

For the Massachusetts Retail Food Inspection Training Program, the coursework is segmented into Tier 1 Food, Tier 2 Food, and Tier 3 Food. Similarly, the Massachusetts Housing Inspection Training Program is divided into Tier 1 Housing, Tier 2 Housing, and Tier 3 Housing.

The overarching goal of the LPHTP is to enhance the existing training infrastructure for local public health professionals (LPHs) who are responsible for enforcing Massachusetts General Laws related to public health services. The program consists of three tiers:

Tier 1 Essential Knowledge: This tier comprises asynchronous eLearning modules covering various LPH topics, delivered through online platforms such as TRAIN MA and ORALearnED (FDA LMS). It provides LPH professionals with the foundational knowledge necessary for understanding key LPH topics.

Tier 2 Instructor Guided Learning: This instructor-led component builds upon the knowledge gained in Tier 1. It offers LPH professionals the opportunity to explore different public health topics in sessions led by experienced instructors. The knowledge acquired in this tier will be applied to real-world public health scenarios in Tier 3.

Tier 3 Applied Practice: This tier focuses on practice-based learning through real public health scenarios. Experienced trainers will guide participants in applying LPH topics, such as food and housing inspections. These practical opportunities are facilitated by the Local Public Health Training Hubs.

Participants must complete each tier sequentially before advancing to the next. Upon completing Tier 3 for either Housing or Food, a trainee will have fulfilled all program requirements. If an individual is already standardized by the FDA for Standard 2 of the Food Training Program, they may bypass Tiers 1 and 2 and proceed directly to Tier 3. Proof of completion of FDA Standard 2 must be submitted to confirm the exemption.

<u>Please note as the Local Public Health Training program grows and evolves over time</u> the prerequisites are subject to change.
